## Section 4 First Aid Measures

**INGESTION:** Call physician or Poison Control Center immediately. Induce vomiting only if advised by appropriate medical personnel. Never give anything by mouth to an unconscious person.

**Suitable Extinguishing Media:** Treat as an oil fire using dry chemical, carbon dioxide, water fog or foam. Do not use water jet. Oil will float on water and can spread fire.

**Protective Actions for Fire-fighters:** In fire conditions, wear a NIOSH/MSHA-approved self-contained breathing apparatus and full protective gear. Use water spray to keep fire-exposed containers cool.

**Specific Hazards:** During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion.

**Containment and Cleanup:** Absorb molten material with inert dry material, sweep or vacuum up and place in a suitable container for proper disposal. Solid material can be scraped up and placed in suitable container for disposal. Wash spill area with soap and water. Surfaces may be slippery, use care to avoid falling.

**Precautions for Safe Handling:** Read label on container before using. Do not wear contact lenses when working with chemicals. Keep out of reach of children. Avoid contact with eyes, skin and clothing. Do not inhale vapors, spray or mist from molten material. Use with adequate ventilation. Avoid ingestion. Wash thoroughly after handling. Remove and wash clothing before reuse.

**Conditions for Safe Storage:** Store in a cool, well-ventilated area. Do not store at temperatures above 90°C (194°F). Keep away from ignition sources. Store protected from light.
