Section 4 First Aid Measures

INGESTION: Call physician or Poison Control Center immediately. Induce vomiting only if advised by appropriate medical personnel. Never give anything by mouth to an unconscious person.

Suitable Extinguishing Media: Carbon dioxide, dry chemical, dry sand, alcohol foam.

Protective Actions for Fire-fighters: In fire conditions, wear a NIOSH/MSHA-approved self-contained breathing apparatus and full protective gear. Use water spray to keep fire-exposed containers cool.

Specific Hazards: During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Dust dispersed in air becomes explosive when exposed to ignition sources.
